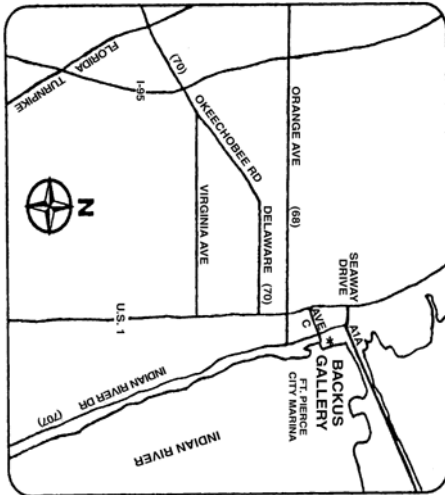

## Rules for exhibiting

1. **ELIGIBILITY:** The annual Four-County Juried Show is selected from actual work (not slides). Each artist may submit up to **three works** for jurying. All entries must be produced in the past three years, not shown previously in the Museum. No copies or reproductions will be accepted. (Copy refers to any duplication of an original — from a photograph, from an original work or from a sketch.) The Museum reserves the right to reject any work that it does not consider suitable.
2. **FEE:** The entry fee of \$25.00 per work is not refundable, regardless of whether your work is exhibited.
3. **PRESENTATION:** ALL WORK MUST BE SUITABLY FRAMED, WIRED AND READY TO HANG. Firmly attach an identification label to the back of each work (or bottom of sculpture) with the artists's name, address, phone number, title of the piece and the retail price (or NFS). **No sawtooth hangers or "D" rings will be accepted. Hanging wire must be at least 2" below top of frame when fully extended. Gallery wrapped with painted edges is permitted.**
4. **SALES:** The Museum will retain a 25% commission on all work sold during the show. Please price each piece accordingly, including this commission. No work is to be removed from the Museum during the exhibit, except when purchased by out-of-town visitors.
5. **MISCELLANEOUS:** Although the A.E. "Bean" Backus Museum & Gallery welcomes exhibit pieces and to the best of our ability will protect them from harm, it will, in no way, be responsible for entries. Any labeling corrections will be handled at the Museum's discretion.
